

# Terms of Use of Website

Welcome to [www.businessforsale.ge](http://www.businessforsale.ge)

This document defines the terms of use of the website and applies to both physical and legal entities. The document also defines the rights and responsibilities of Ltd. Start business solutions (the company), as it owns and administers the web site [www.businessforsale.ge](http://www.businessforsale.ge).

Please read this document and take into account each item, because by visiting a website, by sending a request, by submitting an application, by registering or using any of the services, you automatically agree to the "Terms of Use of Web Site" by conditions provided.

## 1. Introduction to provisions

- 1.1. Visitors of website ( hereinafter "User") can submit their requests or announcements / offers about business sales, investment projects, commercial real estate, land and startups, through [www.Businessforsale.ge](http://www.Businessforsale.ge) (hereinafter "Website").
- 1.2. User can be any physical or legal person.
- 1.3. Sending requests and posting announcements is unlimited.
- 1.4. To publish the announcements on the website, the user is required to register on the website.
- 1.5. Applications posted on the website should only refer to the directions indicated in the item 1.1.
- 1.6. In case of sending a request on the website, the administration of the website will process it and will contact only if there is a relevant announcement in the database.
- 1.7. Some of the website services may be paid, which conditions are specified in the same document.
- 5.4. The Company reserves the right to hide / display the information of contact person on the published announcement.

## 2. Usage and protection of user data

- 2.1. The Company is entitled to receive the requests and applications sent by the user through the website for the purpose of their acquaintance and further reaction.
- 2.2. The company has the right to receive the requests as well as to place the personal information of user in the database: Name, Phone Number, E-mail.
- 2.3. By approving this document, user confirms to transfer the information included in his/her published announcement to interested persons.
- 2.4 The Company has the right to use the personal data registered by the user in order to send their advertising promotions and newsletters to e-mail, social networking and telephone short messages.
- 2.5. If the customer no longer wants to receive advertisements from the company, you should apply to the company's contact information on the website.

### **3. Provide information to the user**

- 3.1. The Company is not responsible for the objectivity of the information provided in published statements.
- 3.2. The company has the right to edit the announcement sent by the user without substantial change and translate it for the purpose of the website.
- 3.3. In order to obtain the access to the contact number of the application published on the website, the user is obliged to undergo authorization process and pay the appropriate amount.
- 3.4. The customer who publishes an announcement on the website can fund its own contact details and make it available to any person.
- 3.5. The company determines the form of payment and the customer offers the card payment in GEL.

### **4. Customer responsibility**

- 4.1. The user must obey the terms defined by this document.
- 4.2. The user is not obliged to perform any of the following actions:
  - 4.2.1. Attempt to enter the protected part of the website, which right to the user doesn't have;
  - 4.2.2. Use any automatic or mechanical process to interfere with the functionality of the website to gain or search any information from the website;
  - 4.2.3. Use of any type of viral program ("worm", "trojan horse", "virus", "spyware", "carding") that will threaten the functioning of the website and endanger its use of security for the user;
  - 4.2.4. Use obscene words or inadequate insults to the company and third parties;
  - 4.2.5. Use the website to create unwanted spam.
  - 4.2.6. Perform the actions or attempts to put an end to the performance of a platform that aims to identify the source code based on the functionality of the web site.
  - 4.2.7. Referring personal data of another person when sending the request or announcement.
  - 4.2.8. The information and visual material available on the website without the permission of the company.

### **5. Company responsibility**

- 5.1. The company is not responsible for the actuality of the announcement published on the website.
- 5.2. The company's competence includes only processing the request and announcement of the user.
- 5.3. The company does not recommend any announcement where there is no contact person

5.4. If the announcement posted on the website is no longer active, the company takes the responsibility of returning the buyer appropriate amount or give him/her access to another phone number.

5.5. The Company reserves the right to establish pricing policy.

5.6. The company does not take responsibility that the user's request would necessarily be satisfied.

5.7. The Company does not assume responsibility that property will be realized as a result of the announcement made by the user.

5.8. Without preliminary agreement, the company may terminate or limit the access to the website or service. At the same time, the company does not take responsibility for the damage that could have been caused by such action.

5.9. The Company does not assume responsibility if the user downloads any kind of information and / or program using a link placed on the website or on the website that will damage user's or any third party's computer (or any part of it) is a mobile phone or other device.

5.14. The company is dismissed from such responsibilities as: telephone networks, computer systems, servers or providers, computer or telephone devices software, e-mail. Technical fault or other technical shortcomings of mail services; Assumptions, errors; Termination and delay in data processing and transmission; Defects; Theft, destruction and unauthorized access to the user's materials.
